Cargo tanks must be loaded uniformly whenever a 46 CFR Subchapter "O" cargo is carried; for trim purposes, the weight of cargo in each tank may exceed the uniformly loaded tank cargo weight by at most 5 percent.

In accordance with 46 CFR, Part 39, excluding part 39.40, this vessel's vapor control system has been inspected to the plans approved by Marine Safety Center letter Serial C1-1303585 dated 23Oct13, and found acceptable for collection of bulk liquid cargo vapors annotated with "Yes" in the CAA's VCS column.
